SANCTION ORDER

Sanction of the competent authority is hereby conveyed to incur an expenditure of Rs.24.00 lacs (Rupees Twenty four lacs only) on account of payment to Irrigation & Flood Control Department under "My Delhi, I Care Fund" in respect of Sub-Division Karawal Nagar, for following works:-

Sanction is conveyed for withdrawal of the above amount in simple receipt format. Further, sanction is subject to submission of work completion certificate alongwith utilization certificate with in period prescribed in GFR.

This sanction is issued in exercise of the powers conferred on the department by the Services Department with the concurrence of the Finance Department Govt. of NCT of Delhi vide order No. F 2/12/97/SI dated 12.02.1997 and in consultation with the accounts Functionary of the Department.

The expenditure incurred is debitible under Major Head "2053" M 3(3) (1) (2) Citizen Care for Habitat Fund for the year 2014-15 (Plan). The funds to the tune of Rs. 24.00 lakh (Twenty Four lacs only) is placed that is disposal of Executive Engineer CD-IV I & FC Department. This sanction is subject to the observation of following codal formalities.

Administrative Approval and expenditure sanction is subject to following of codal formalities:-

The implementing agency will open an account at the district level for deposition of the funds received from the concerned Deputy Commissioner as advance for executing the scheme as "Deposit Work".

1. The Powers to realize funds from this account to the contractor should be with the District Level functionaries of the implementing agency and in no case, it should be centralized at the HQs.
2. On receipt of sanction order, the implementing agency will start the process of execution like inviting tenders without waiting for deposition of funds.
3. The award of work & execution will be taken up immediately on receipt of the funds from the Deputy Commissioners (Revenue).

4. The implementing agency will ensure that the work is started at the site within 30 days of receipt of sanction order in case of work up to Rs.2.0 Lakh (Rupees Two Lakh only).
5. The Officers of the implementing agency will inspect the works from time to time during execution to ensure quality and quantity of the work as per the estimate & completion of work in prescribed time limit.
6. The implementing agency will maintain accounts of the funds deposited and will submit the progress of execution of works and utilization of funds from time to time to the Deputy Commissioner (Revenue).
7. The implementing agency will ensure that the work is completed within 90 days after award of work.
8. The implementing agency will display a sign board that the work has been executed under the "My Delhi, I Care Fund" and will also mention the amount spent on the date of commencement and date of completion of the work.
9. The implementing agency will submit photographs of the work on completion to the Deputy Commissioner (Revenue).
10. The implementing agency will submit the final bills, utilization certificate and unspent amount of each scheme to the Deputy Commissioner (Revenue) within 10 days of completion of the work to enable to settle the accounts with PAO.
11. The interest generated in the account will not be utilized without prior approval of the Deputy Commissioner (Revenue).
12. I & FC Department shall not take up the same work in the same locality under PWD funds.
13. Further, this sanction is issued subject to the condition that the incurring expenditure by the Department (CPWD) as per observation of codal formalities.
