This public notice is issued to all interested persons/owners in compliance of order passed by the Hon'ble Supreme Court in SLP© No. 18514/2006, 18617/2006 etc. These cases are in reference of land notified U/s 4 vide notification no. In this case the Hon'ble Supreme court has directed the competent authority to invite objection U/s 5-A of the Land Acquisition Act, 1894 pursuant to the notification dated 01.06.1995.
