| Type-I to IV | Rs. 150/- | 55 times of normal licence fee |
| Type-IV Special and above including Hostel | Rs. 220/- | 65 times of normal licence fee |

In cases, where damage charges have been recovered on previous rates between 01/01/2013 to till date, the difference between previous rates and new rates of damage charges may be recovered.
