**CORRIENGDUM TENDER NOTICE-2**

Reference to queries received on email and sought by the firms visited to this Directorate in the tender regarding "**limited tender for printing of dengue prevention awareness pamphlets & stickers**", following is further clarified:-

1. The firms under MSME shall be exempted from EMD as per rule.
2. EMD will be accepted in the form of FDR or Bank Guarantee (BG) in addition of Demand Draft (DD) (Clause 4 "EMD and performance guarantee" of tender document)
3. The date of award of work & submission of requisite performance security may be read as 16/10/2019 instead of 15/10/2019 (Sl. No. 4 of Clause 3 "Submission of Bids schedule" & Clause 7 "Work Award" of tender document)
4. The 25 Kit written in Clause 8 "Penalty Clause" (Para 1, second line) in Tender Document may be read as 25 Lakh pamphlets and 75 Lakh stickers.
5. The date of supply of material may be read as 23-10-2019 instead of 22-10-2019 (Sl. No. 5 of Clause 3 "Submission of Bids schedule")
6. The penalty as mentioned in Clause 8 "Penalty Clause" at Sl. No.2 & 3 shall be levied 2% (on 24-10-2019) and 3% (on 25-10-2019), respectively, on the total work only.
7. The rate shall be quoted for 25 lakh pamphlets and 75 Lakh stickers including GST. The specification shall be as per Clause 2 "Scope of Work" of the tender document.
8. The EMD shall be forfeited, if the qualified bidder shall not submit the requisite performance security latest by 16/10/2019 till 5:00 pm.
9. The performance security shall be forfeited in case of breach of any terms and condition of the contract i.e. if the material supplied does not meet the specification as per tender document, the work could not completed up to 25-10-2019 by 5:00pm, etc.

Rest of the terms and conditions will remain same.
