



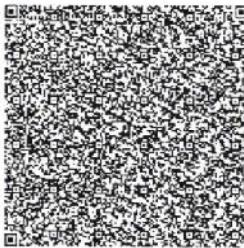

Now the terms and conditions are as under:-

Medical Superintendent of the AAAGH accord of contract for Laundry services on outsource basis in favour of the firm M/s Rehmat Ali Drycleaners for the period of one year extendable to additional one year from the date of award of contract on mutually agreed on same rates terms & conditions and satisfactory performance of the contractor in two batch of six month each.

1. The contractor is fully responsible for the quality.
2. Contractor must access the business before participation in the tender.
3. Contractor will follow all the rules regulations of concerned department/Central Government/Government of N.C.T. of Delhi.
4. Tenderer should preferably have his own Ghat, If not hospital may provide space however water and electricity charges will be as per consumption.
5. The contractor should submit the address ID, medical and police verification report of employees engaged by him. The laundry staff engaged must be above the age of 18 years.



6. The contractor should not assign the present contract to any person or allow any person to interfere in the management of Laundry services.

7. If the contractor fails to render services to the satisfaction of the hospital authority the letter has been to get the work done by

period on contract risk and expenses.

8. The provisions of appropriate men power material supplies required for the process of laundry services shall be borne by the contractor. The necessary appliances and storage facility like Almirah, racks etc shall be ensured by the contractor.

9. The Complete job of collection of dirty linen to various department poor house mortuary and administrations shall be carried out by the contractor at appropriate time.

10. The contractor should ensure dis-infection of the linen before washing, sludging hydroextraction, drying, repairing and ironing of linen is the responsibility of contractor.

11. The time of collection of linen should be regular as per the department depending on the quantum of the linen he has to return the washed linen within 2 days from receipt of linen to the department failing which Rs.200/- on 1st instance and Rs.500/- on subsequent shall be levied as penalty.

12. For damaged linen penalty will be present value of linen plus Rs.200/- on 1st instance and then Rs.500/- on subsequent.

13. EMD submitted by successful bidder shall be retained by the hospital as Security Deposit. The security Deposit shall be released after expiry of the validity of the tenders. The EMD of the unsuccessful bidder shall be released after award of contract to the successful tender.

14. Any misbehaviour or misconduct by the employee shall be the responsibility of the contractor any loss due to negligence or mishandling by the laundry staff during laundry process is the responsibility of the contractor the contractor is liable for the



15. The contractor should ensure that there is no pollution due to the laundry services.

16. Bidder shall be fully responsible for any loss/damaged to himself, any worker engaged by him during collection/transportation/washing or handling machine. He shall also be responsible for disbursement of the wages to the workers as per Labour Law.
