

HEARING NOTICE

Whereas, vide notification No. F-ADM/SE/LAC/2016/506 dated 2.09.2019, the land bearing Kh. No. 6 min (8Bigha/6727.05 Sq. Mtr.), Kh. No. 8 min (1-8 Bigha/1150 Sq. Mtr.), Kh. No. 13 min (3-16 Bigha/3164.5 Sq. Mtr.), Kh. No. 40 min (2-17 Bugha/2360 Sq. Mtr.), Kh. 156 min (11-5 Bigha/9401 Sq. Mtr.), Kh. No. 221 min (8-18 Bigha/7440 Sqr. Mtr.) of Nagli Razapur in the Sub Division Defence Colony of District South East were notified under section 11(1) of the Right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) for infrastructure project i.e. construction of 3rd Phase of Elevated Road on Barapulla Nallah from Sarai Kale Khan to Mayur Vihar, New Delhi and published by the Collector in the part 1 of the NCT of Delhi Gazette, dated 5th September, 2019.

The undersigned for Rehabilitation & Resettlement shall conduct a hearing of the interested persons on 15.12.2020 at 11.00AM in the Conference Hall of District South East, Lajpat Nagar, New Delhi under section 16(5) of the Right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, in such manner and within such time as may be prescribed, which shall include:-

- Particulars of land and immovable properties being acquired of each affected family.
- Livelihoods lost in respect of land losers and landless whose livelihoods are primarily dependent on the land being acquired.
- A list of public utilities and Government building which are affected or likely to be affected, where resettlement of affected families is involved.
- Details of the amenities and infrastructure facilities which are affected or likely to be affected families is involved and
- Details of any common property resources being acquired.
