DSEALING ORDER

Vide sealing order dated 05.09.2013 the premises of Sh. Umesh Kumar S/o Sh. Tulsi Ram R/o H.No. 11, Tukhmipur Extn, Karawal Nagar, Delhi-110094, was sealed in order to recover the amount Rs. 20,000/- (Twenty Thousand Only) as he had employed Child/Bounded Labour at the above said premises and recovery of Rs. 20,000/- had become due against him in pursuance of the order of the Hon'ble High Court of Delhi in WP (C) No. 9767/2009 dated 15.07/2009.

As per the labour officers East & North-East, Labour Department office letter no. DLC/NE/Lab/2015/2931 dated 16/01/2015 the employers Sh. Umesh Kumar S/o Sh. Tulsi Ram R/o H.No. 11, Tukhmipur Extn, Karawal Nagar, Delhi-110094, has deposited Rs. 20,000/- (Twenty Thousand Only) in favour of Delhi Child Labour Rehabilitation cum welfare society, vide DD No. 698224 dated 30/10/2014. The age of child 1.) Sunny S/o Sh. Mahesh, 2.) Raj Kumar S/o Sh. Lalji Dass 3.) Shiv Mangal S/o Sh. Ram Chander are declared 15 to 18 years by School Certificate, they do not fall in the category of child labour The Employer has also filed order/acknowledgement of Child Welfare Committee regarding payment of before CWC as payment of wages.

The Police authorities have also lodged an FIR against the employers. According to the letter received from labour officer the employers has completed the necessary action and further no action is to be initiated against the offending employers by them.

In view of above, the premises of Sh. Umesh Kumar S/o Sh. Tulsi Ram R/o H.No. 11, Tukhmipur Extn, Karawal Nagar, Delhi-110094 is hereby ordered to be de-sealed.
